Dr. Stahl studied law, economics and business administration in Austria, Italy, the United Kingdom and the United States. He graduated with Master of Laws degrees from the University of Leicester in European Law and from the University at Buffalo Law School, SUNY, in U.S. Law. He also holds an MBA from the University of Chicago's Booth School of Business and a post-graduate Certificate in Taxation from the Fordham Graduate School of Business. For his most recent work *Capital 2.0 – Capital Formation and Legal Risk in a New Global Economic Order. From FIAT to EXIT* he was awarded a PhD in Law from the University of Westminster.

During the past 30 years he personally led, financed, managed, grew, sold or advised emerging growth companies and organizations from industries as diverse as software, e-commerce, private radio, digital, streaming and mobile media, bio life science, medical technology and pharmaceuticals to such traditional industries as real estate and construction, wine and food, marketing and customer care as well as education and training companies.

From the early nineties into the millennium Lukas had been active for over a decade as co-founder, president and CEO of a European-wide group of e-commerce, marketing, media and consulting companies based out of Austria, Belgium and the United Kingdom and as managing director of a construction company developing residential real estate projects in Vienna, Austria.

As of the young age of 28 Lukas was leading the bipartisan Vocational Education and Training Initiative of the Austrian Government from 1997 to 2000 on behalf of the Federal Chancellor, the Prime Minister, of Austria. During his service Austria reported the least youth unemployment in the entire European Union.

For his work on co-founding Vienna's private university for applied sciences in European Management and Business Administration and Banking and Finance dedicated specifically to professionals in full-time employment, Dr. Stahl was named Austria's "Young Social Entrepreneur" to the United Nation's Common Futures Forum.

In 2004 Lukas moved full-time to the United States where for six years before founding his own firm he helped build the European Practice of a leading securities law firm for mid-market companies in Los Angeles and New York.

In his new home in the United States Lukas still cares for his old home Austria as the co-founder and President of the nonprofit foundation Friends of the Austrian Cultural Forum New York. In the United Kingdom he continues to support the University of Leicester as a Member of the University's Standing Committee of the Convocation.

Lukas speaks German, English and Italian. He also reads Spanish and French.
